OTHER BUSINESS:

City Manager's Report – Interim City Manager/City Attorney Bryan Carter said the City will be receiving COVID-19 stimulus funds reportedly just under \$39.7 million in two installments. The four specific categories those funds can be applied to are: 1) assistance for negative economic impact, 2) premium pay or grants premium pay for essential work, 3) recovery of loses and governmental revenue, and 4) investments in water, sewer or broadband infrastructure. A work session will be held sometime in late April or early May after the Treasury Dept. issues regulations regarding the expenditure of the funds. Meetings to review the FY2022 budget will be held May 3 through 12 in a slightly different format. The Water Protection Line Mtce. facility will not be advertised for sale as previously reported. At a request by Council to reconsider that decision and evaluate alternative uses of it, Parks and Police Departments have said they could use it for storage so the sale will be postponed. If any unique interest arises in the property, it will be brought back before the City Council. City staff is still negotiating with ASM Global on a consulting contract for the Krug Park amphitheater project. ASM Global has begun the process of soliciting firms to perform a feasibility and economic impact study. Clean Sweep is scheduled for April 1-7.

Councilmember O'Dell asked if City employees will now be able to drive two to a vehicle with the mask mandated lifted. Mr. Carter said new guidelines will be sent out to City employees tomorrow regarding when masks must be worn while working. Each department is reviewing their finances from the last year and evaluating where losses occurred and a method to recoup those losses will be proposed.

Agenda No. 45943-44 – Pat Dillon, 2731 Frederick Ave., spoke on behalf of some Mosaic Life Care doctors who recommend and request that the City Council let the declaration continue naturally and expire on its natural time frame in three or four weeks. They are also concerned if there is a spike, that it will be very difficult to asking the community to go back to masking.

Colleen O'Brien, 4334 Stonecrest, thinks wearing masks has gone way to long and hurting businesses, people and children.
